 SUBJECT: **August 2014 Sales Tax Distribution (June 2014 Activity)**

*Monthly comparisons (August):* August sales tax receipts (for June 2014 activity) were \$2.0 million which is \$186k (10.2%) over August 2013 and \$301k (17.5%) over the August adjusted budget.

*Year-to-date comparisons (January through August):* 2014 is currently \$592k (4.4%) over 2013 and \$596k (4.5%) over the 2014 year-to-date budget. See the year-to-date comparison, by sector, below.

*Variances from prior years:* The 2013 year-to-date amounts include major construction projects completed in 2013, which significantly skew the 2013-2014 comparison in the construction sector. *Excluding these one-time items, 2014 is \$1.3 million (9.9%) over 2013 and the construction sector is \$296k (27%) over 2013.*

The manufacturing sector is significantly higher in 2014 because Boeing changed their reporting method utilizing a direct pay permit beginning with the November 2013 return. Using this method Boeing stopped paying sales tax to vendors and now directly reports all use tax based on shipping destinations. Going forward this will result in higher use tax being reported from Boeing and less sales tax from other sectors. The transportation category of this sector is \$561k (106%) over 2013. *Excluding transportation, this rest of this sector has decreased \$22k (7.0%) from 2013.*
