#### OTHER THINGS TO CONSIDER

Check to see if Puget Sound Clean Air Agency need notification prior to proceeding with demolition.

If structure to be demolished is over 30,000 sq. ft. - [SEPA checklist](#) is required.

Construction debris is to be taken to an approved disposal facility. [See King County Solid Waste](#) for information. If you have questions about disposing of asbestos, check with Puget Sound Clean Air Agency [PCCCA](#) regarding requirements.

The Lot is to be restored to original condition.

I certify that the information on this application furnished by me is true and correct and that the applicable requirements of the City of Renton will be met. I understand that this application is valid for one (1) year from the application date. If a permit is not issued during this time period, the application will become void. This application does not constitute a permit to work. Work is not to commence until the building permit is posted on premises where work is to be performed. Certification is hereby rendered that no work is to be done except as described, and that all work shall conform to applicable codes. Work in public rights-of-way and/or utility easements are not authorized under this application.
