The Renton City Council will consider the following:

An Ordinance of the City of Renton, Washington, extending and amending the Interim Zoning Control established by Ordinance No. 5974 in response to the operational limits on businesses during the COVID-19 declared public health emergency by (1) Extending the temporary "Economic Recovery Revocable Right-of-Way Permit" for businesses; (2) Extending the temporary "Economic Recovery Signs" for businesses; and (3) amending the Interim Zoning Control to waive the requirement to obtain a temporary use permit for the temporary expansion of a business into an adjacent vacant space in a multi-tenant building; authorizing the temporary designation of a limited number of existing public parking stalls within the Center Downtown Zoning District to support parking for short-term curbside pick-up or to go orders from businesses; temporarily waiving parking fees for parking periods of up to 10 hours within the City's City Center Parking Garage located at 655 South 2nd Street; providing for severability; declaring an emergency; and establishing an effective date.
